The registration fee is a non-refundable fee that is due at the time of registration. This is a separate fee and does not go toward the first month's tuition.

Tuition is due by the 1st day of each month and is considered late after 2 pm on the 3rd day of the month, regardless of weekends or school holidays. Fees are based on the total number of days scheduled for the year, then divided by 9 months, so monthly tuition fees are consistent. Tuition is not pro-rated based on the number of school days. Tuition is prepaid one month in advance starting August 1.

A returned payment fee will be assessed on any form of payment returned for insufficient funds. A late fee will be assessed after the 3rd of each month and is due when that month's tuition is paid. If the late fee is not paid prior to the end of the month, the account is considered delinquent.

Two supply fees will be charged on August 1st and January 1st, and can be paid in advance. Failure to pay supply fees on time will result in your child losing their enrollment.

If an account is in arrears for three weeks after the due date, your child/ren will not be allowed to attend class unless arrangements have been made with the director of Hope Rising Preschool.

Enrolled students may drop in for a full day of preschool on non-scheduled days. They may also drop in for AM extended care or AM/PM extended care on their regularly scheduled days. All drop-ins must have prior approval from the director.

For those using extended care in the afternoon, our late pick up policy is as follows:
\$10 per minute after 4:45 pm. If a parent is late three times in a semester, the child will be unenrolled in the afterschool program.

Any child that is picked up late after 2 pm, will be charged as follows:

2:00-2:15 - \$15 / 2:16-2:30 - \$25 / 2:31- \$50

This fee will be applied to your account.

Changes to enrollment after June 1st will result in an administrative fee of \$25 for the first change and \$50 for any changes thereafter. No tuition refunds will be given towards September tuition after August 1st. A 30-day written notice will be needed to withdraw by July 1st. *To make changes, please fill out the 'Change of Enrollment' form found on our website.*

Electronic Processing Fee is a one time fee of \$50 (per family) payable at registration, if tuition will be paid by credit or debit card. If paying by credit card, an additional \$15 convenience fee will be charged per transaction.

To withdraw a student from the program, you will provide a 30-day notification by filling out our 'Change of Enrollment' form found on our website. Notices must be given by 2 pm on the 15th of the month to stop payment for the following month. If notice is received after 2 pm on the 15th or notice is not given, you will be responsible for the next month's tuition. *No changes can be made to the months of December and May.*

HRP does not prorate fees, issue refunds, or provide make-up days for closures caused by circumstances beyond our control (power or water outage, gas leak, inclement weather)
